Eligible Candidates (1) must maintain their principal office in jurisdiction they seek to represent, and (2) must be voting members of the ICA In good standing for a minimum of 1 year prior to running, unless no other available candidate is in the jurisdiction who has been a member for a minimum of 1 year.

This form must be in the ICA offices **no later than November 19, 2022.** **Fax or email preferred; the postal service is still terribly slow.** You may submit this form by fax 1-703-528-5023 or email it to chiro@chiropractic.org. You will receive a letter acknowledging receipt of your form within 48 hours and be provided additional election details.



Online Voting: This year we are conducting the election online through a secure voting system, so that all active ICA members who are eligible to vote may participate. You will receive an email with the sample ballot for your jurisdiction. This sample ballot and instructions on how to go online and vote will be emailed to you by November 25, 2022. You will have until December 26, 2022, to cast your vote online.
